

FIRST PROTOCOL OF AMENDMENT

Trade, Investment and Labour Mobility Agreement First Protocol of Amendment

The Governments of British Columbia and Alberta, Parties to the *Trade, Investment and Labour Mobility Agreement* (the "Agreement"), hereby agree to make the following amendments to the Agreement:

- 1. Article 6(3) is amended by adding "prohibition or" between "unless the" and "restriction".
- 2. Article 7 is amended by adding the following as paragraph 6:

"The provision of notice under paragraph 2 is without prejudice as to whether the measure is consistent with this Agreement."

3. Article 11 is amended by renumbering the current paragraph 1 as paragraph (1)(a) and by adding the following as paragraph (1)(b):

"Parties and their municipal governments shall consider options to provide for the reconciliation of municipal business licenses. Until such time as the matter is resolved, Article 11(1)(a) will not apply to municipal business licenses."

- 4. Article 13 is amended as follows:
 - (i) adding the following as paragraph 8:

"Occupations requiring certification, registration or licensing prior to commencing work in only one of the Parties shall be listed on the Labour Mobility Transparency List in Appendix II. This list shall also be published on www.tilma.ca.";

(ii) adding the following as paragraph 9:

"A Party shall advise the other Party immediately of the addition or deletion by the advising Party of any occupation on the list of occupations in Appendix II and any change made by that Party to the title of any occupation included on that list."

- (iii) adding the following as paragraph 10:
- "A Party shall:
- (a) amend its list of occupations in Appendix II after any change made by it to that list pursuant to paragraph 9;
- (b) maintain an up to date copy of its list of occupations in Appendix II;

- (c) forward a revised list of occupations in Appendix II to the other Party after every such change; and
- (d) ensure a revised list of occupations in Appendix II is published on www.tilma.ca after every such change."; and
- (iv) adding the following as paragraph 11:

"This Article 13 does not apply to occupations that are regulated by one Party only, regardless of whether it is listed in Appendix II. Once a Party regulates a previously unregulated occupation that is regulated by the other Party, that occupation is bound by the terms of this Agreement, regardless of whether such occupation is listed in Appendix II."

5. Article 14 is amended by:

(i) deleting paragraph 1 and replacing it with the following:

"Further to Articles 3 and 4, Parties will provide open and non-discriminatory access to procurements of the following government entities:

- (a) departments, ministries, agencies, boards, councils, committees, commissions and similar agencies of a Party where the procurement value is:
 - (i) \$10,000 or greater for goods,
 - (ii) \$75,000 or greater for services, or
 - (iii) \$100,000 or greater for construction; and
- (b) regional, local, district or other forms of municipal government, school boards, publicly-funded academic, health and social service entities, as well as any corporation or entity owned or controlled by one or more of the preceding entities where the procurement value is:
 - (i) \$75,000 or greater for goods,
 - (ii) \$75,000 or greater for services, or
 - (iii) \$200,000 or greater for construction."; and
- (ii) adding the following as paragraph 5:
- "5. Entities covered by this Article that participate in group purchasing activities through buying groups shall ensure that the activities of such buying groups are carried out in a manner consistent with this Agreement and neither Party shall direct the procurement activities of buying groups in a manner inconsistent with this Agreement."
- 6. Article 25(6) is amended as follows:

- (i) replacing "its" with "a";
- (ii) adding ", 3" between "1" and "or"; and
- (iii) adding ", as applicable," after "person".
- 7. Article 25(10) is amended by adding ", 3" between "1" and "or".
- 8. Article 27(2) is amended by:
 - (i) adding "also" between "will" and "provide"; and
 - (ii) replacing "one of the disputants" with "that complainant".
- 9. Article 27(10) is amended by replacing the comma before the word "If" with a period.
- 10. Article 32(3) is amended by replacing the comma at the end of the paragraph with a period.
- 11. Paragraph 1 under the "General Exceptions" section in Part V is amended by:
 - (i) deleting the word "or" at the end of (e);
 - (ii) replacing the period at the end of (f) with a semi-colon and placing the word "or" after that semi-colon; and
 - (iii) adding the following after (f):
 - "(g) Subject to Article 4, land use."
- 12. The "Government Procurement" section in Part V is amended by adding the following as paragraph 3:
 - "3. Articles 3, 4 and 14 do not apply to any procurement undertaken by non-governmental bodies that exercise authority delegated by law."
- 13. Paragraph 1 (e) under the "Regional Economic Development" section in Part V is amended by adding "(1)" after "12".
- 14. The list in paragraph 1 under the "Labour Mobility" section in Part VI is replaced by the list in Appendix A to this Protocol of Amendment.
- 15. Paragraph 1 under the "Transportation" section in Part VI is deleted and Paragraph 2 is renumbered to Paragraph 1.
- 16. The following definition is to be included in Part VII after the definition of "business subsidy":

"buying group means a group of two or more members which combines the purchasing requirements and activities of the members of the group into one joint procurement process. Buying groups include cooperative arrangements in which individual members administer the procurement function for specific contracts for the group, and more formal corporate arrangements in which the buying group administers procurement for group members. Buying groups may involve a variety of entities, including public sector, private sector and not-for-profit organizations."

- 17. The definition of "government entity" found in Part VII is amended by:
 - (i) adding "as well as any corporation or entity owned or controlled by any such form of municipal government" after "government" in paragraph (c); and
 - (ii) adding "as well as any corporation or entity owned or controlled by one or more of the preceding entities" after "entities" in paragraph (d).
- 18. The definition of "standard" found in Part VII is amended by adding the word "or" after the comma in (c).
- 19. Add Appendix II on the next page after the last page of Appendix I and entitle it "Labour Mobility Transparency List".

The amendments to the Agreement contained in section 3 and subsection 5(i) of this Protocol shall enter into force on April 1, 2009, subject to the prior exchange of written notifications certifying the completion of each Party's internal approval procedures. All other amendments to the Agreement contained in this Protocol shall enter into force immediately upon exchange of written notifications certifying the completion of each Party's internal approval procedures.
